



MANDATORY STANDARD OPERATING PROCEDURE (MSOP)

In line with the announcement by the Malaysian Government for the opening of the operation under National Recovery Plan Phase 1. The Club operations will be resumed effective **SATURDAY, 21st AUGUST 2021** in accordance with the Mandatory Standard Operating Procedure by NSC, KBS & MGA are as follows:-

1. Only Members who have completed 14 days after 2nd dose of Vaccination are allowed to enter and use club facilities. **(TO PRODUCE DIGITAL VACCINATION CERTIFICATE AS PROOF OF EVIDENCE)**
2. **Operation Hours:**
Operation hours will be from 7.00 am to 8.00 pm
3. **Booking:**
Booking is only allowed to be made one (1) day earlier from 7.00 am to 5.00 pm through club phone number at: **06-6775787 / 6775277** or via WhatsApp at: **019 – 3904564**. Booking will be based on 1st come 1st serve basis. **NO WALK – INS** are allowed.
Golf course shall operate at 60% of total flight capacity per session (Limit to 12 flights only). There are 2 sessions per day (Morning/Afternoon). Golfers shall register 20 minutes before tee time.
4. **Buggy Usage:**
Single usage of buggy is mandatory even if Plastic Separator is installed.
5. **Caddy:**
Sharing of caddy is NOT allowed. Caddy shall NOT drive the buggy nor seat together with the golfer. Caddy shall ride at the back of the buggy.
6. **Walking Golfers:**
Weekdays:
7.00 am until 8.45 am at 2nd Nine.
4.00 pm onwards at 1st Nine and 4.30 pm onwards at 2nd Nine.
Weekends:
4.00 pm onwards at 1st Nine.
7. **F&B Operations:** DINE-IN is allowed for those who have completed 14 days after 2nd dose of Vaccination. **(TO PRODUCE DIGITAL VACCINATION CERTIFICATE AS PROOF OF EVIDENCE).**
8. **JUMBO FLIGHTS:** NOT ALLOWED.
9. **Driving Range:** SHALL OPERATE AT 60% OF TOTAL BAY CAPACITY
10. **Swimming Pool:** SHALL BE CLOSED
11. **Changing room** and **shower facilities:** SHALL BE CLOSED.

Please be reminded golfers with fever or cold or cough or any other symptoms of **COVID 19** shall be prohibited from entering the Golf Club. We seek members' fullest co-operation to abide by the **SOPs** and practice **SOCIAL DISTANCING**, failing which the member shall be liable to disciplinary action.
